



REQUIREMENTS FOR COMMERCIAL DRIVERS

IMPORTANT: TO RENEW ONLINE, VISIT WWW.DMV.NY.GOV/LICRENEW. TO RENEW BY MAIL, SEND THIS COMPLETED/SIGNED APPLICATION WITH YOUR RENEWAL OR YOUR CDL WILL NOT BE RENEWED

ALL COMMERCIAL DRIVERS MUST:

1. Answer all questions on this form
2. Sign this form
3. Print your name and driver license number, and
4. Return this form to New York State DMV when you renew your CDL **along with:**
 - a. your completed driver license renewal application,
 - b. an eye test report,
 - c. a copy of your Medical Examiner's Certificate and waivers (if applicable), and
 - d. payment

1. **Did you have a driver license from the District of Columbia (DC) or any US state, other than New York, in the past 10 years?** Yes No If 'Yes', clearly print the names of all of the states or DC:

IMPORTANT! READ THIS NOTICE before continuing: NYSDOT regulations require that New York commercial drivers meet federal qualification standards pursuant to 49 CFR 391, except for drivers who meet the eligibility requirements for a K (CDL intrastate only) or A3 (municipal/school operation only) restriction. For an explanation of the federal 49 CFR Part 391 requirements and eligibility requirements for the K and A3 restrictions, see form MV-44.5, Federal Requirements for Commercial Driver License Applicants, available on the DMV website at www.dmv.ny.gov/forms/mv445.pdf and at Motor Vehicles offices.

2. **Do you certify that you meet the federal requirements set forth in 49 CFR Part 391 and have a valid Medical Examiner's Certificate?** Yes No

If '**Yes**', you **must** submit a copy of your Medical Certificate and any Skills Performance Evaluation Certificate or Diabetes or Vision waiver, if applicable.

If '**No**', you must answer questions 3a and 3b below:

- 3a. **Will your commercial driving be limited to municipal and/or school operations ONLY?** Yes No

If '**Yes**', you will receive a CDL with an A3 restriction limiting your commercial driving to municipal/school operations.

- 3b. **Will your commercial driving be limited to within New York State ONLY?** Yes No

If '**Yes**', you will receive a CDL with a K restriction limiting your commercial driving to within NY only if you received your first NY CDL before 9/9/99.

Note: If you received your first NY CDL on or after 9/9/99, you are not eligible for a CDL with a K restriction.

If all answers to questions 2, 3a and 3b are **NO**, you are not eligible for a CDL. You must go to a Motor Vehicles office to renew your license as a Non-CDL Class D or E.
