SELF-CERTIFICATION OF CMV DRIVING TYPE

Driving Type (Select only **one** type from the three below):

- Non-excepted interstate** - Your selection left and signature below certifies you operate or may operate a commercial motor vehicle (CMV) in interstate commerce and are subject to, and meet the qualification requirements of, 49 CFR part 391, shown on the back of this form. **Most CMV operation is “non-excepted interstate”**. If you are qualified to operate a vehicle in non-excepted interstate commerce, DMV recommends you certify this driving type, even if most of the driving you do currently is excepted interstate or non-excepted intrastate. If you qualify and certify non-excepted interstate, you may operate a CMV in excepted interstate and non-excepted intrastate also.
- Excepted interstate** - Your selection left and signature below certifies you operate or expect to operate a CMV in interstate commerce but engage exclusively in transportation that is excepted, under 49 CFR parts 390.3 (f), 391.2, 391.68 or 398.3, from all or parts of the qualification requirements of 49 CFR part 391, shown on the back of this form. Some examples of excepted interstate operation are school bus operations, transport by government entities, some farm operations, and bee transportation. You must still meet medical qualifications for issuance of an Oregon CDL. **Your CDL will be restricted** to prohibit operation of a CMV in non-excepted interstate commerce but you may operate a CMV in non-excepted intrastate commerce.
- Non-excepted intrastate** - Your selection left and signature below certifies you operate or expect to operate a CMV in intrastate commerce only and are not subject to the qualification requirements of 49 CFR part 391. You are still subject to Oregon state qualification requirements. **Your CDL will be restricted** to prohibit operation of a CMV in non-excepted interstate commerce but you may operate a CMV in excepted interstate commerce.

Note: Interstate commerce means trade, traffic, or transportation in the U.S.: (1) Between a place in a State and a place outside of such State (including a place outside the U.S.); (2) Between two places in a State through another State or a place outside the U.S.; or (3) Between two places in a State as part of trade, traffic, or transportation originating or terminating outside the State or the U.S. **Intrastate commerce** means any trade, traffic or transportation in any State which is not described in the term “interstate commerce”.

49 CFR Part 391 Qualification Requirements

If you will not meet the following federal qualification requirements, you may not operate a commercial motor vehicle in non-excepted interstate commerce but may be eligible to operate in interstate excepted commerce and intrastate commerce.

Part 391.11 – General qualification of drivers.

- (a) A person shall not drive a commercial motor vehicle unless he is qualified to drive a commercial motor vehicle. Except as provided in Part 391.63, a motor carrier shall not require or permit a person to drive a commercial motor vehicle unless that person is qualified to drive a commercial motor vehicle.
- (b) Except as provided in subpart G of this part, a person is qualified to drive a motor vehicle if he/she:
 - (1) Is at least 21 years old;
 - (2) Can read and speak the English language sufficiently to converse with the general public, to understand highway traffic signs and signals in the English language, to respond to official inquiries, and to make entries on reports and records;
 - (3) Can, by reason of experience, training, or both, safely operate the type of commercial motor vehicle he/she drives;
 - (4) Is physically qualified to drive a commercial motor vehicle in accordance with subpart E—Physical Qualifications and Examinations of this part;
 - (5) Has a currently valid commercial motor vehicle operator's license issued only by one State or jurisdiction;
 - (6) Has prepared and furnished the motor carrier that employs him/ her with the list of violations or the certificate as required by Part 391.27;
 - (7) Is not disqualified to drive a commercial motor vehicle under the rules in Part 391.15; and
 - (8) Has successfully completed a driver's road test and has been issued a certificate of driver's road test in accordance with Part 391.31, or has presented an operator's license or a certificate of road test which the motor carrier that employs him/her has accepted as equivalent to a road test in accordance with Part 391.33.

Part 391.13 Responsibilities of drivers.

In order to comply with the requirements of Part 392.9(a) and § 393.9 of this subchapter, a motor carrier shall not require or permit a person to drive a commercial motor vehicle unless the person:

- (a) Can, by reason of experience, training, or both, determine whether the cargo he/she transports (including baggage in a passenger-carrying commercial motor vehicle) has been properly located, distributed, and secured in or on the commercial motor vehicle he/she drives;
- (b) Is familiar with methods and procedures for securing cargo in or on the commercial motor vehicle he/she drives.
